MDP BROAD BASED BLACK ECONOMIC EMPOWERMENT (MDP B-BBEE)

The B-BBEE MDP is an initiative of the Department of Trade, Industry and Competition (**the dtic**) to provide a standardised national curriculum for the B-BBEE verification industry.

Unisa's Graduate School of Business Leadership is one of only two institutions that were elected to partner with **the dtic** to deliver this programme.

WHO SHOULD ATTEND?

The target group for this programme is B-BBEE verifiers, B-BBEE consultants, private and public practitioners. This programme will provide candidates with the tools and the ability to work within the provisions of the B-BBEE Act 53 of 2003 and its various legislative updates as well as other relevant policies. Qualified candidates can apply to work in the related B-BBEE space or practice as a Verification Professional.

The MDP B-BBEE provides for two options:

Option 1: MDP B-BBEE (fast track)

The duration of the fast track programme is **three months**. Eligible candidates should hold a Senior (Matric) Certificate and 3 years' B-BBEE working experience.

Option 2: MDP B-BBEE (normal track)

The duration of the normal track programme is **six months**. Eligible candidates should hold a Bachelor's degree and 3 years' B-BBEE working experience.

WHAT ARE THE BENEFITS?

This programme will provide candidates with the tools and the ability to work within the provisions of the B-BBEE Act 53 of 2003 and its various updates as well as other relevant policies.

Qualified candidates can apply can apply to work in the related B-BBEE space or practice as a Verification Professional.

ASSESSMENT

Assessment is based on the submission of assignments together with a portfolio of evidence.

STUDY SCHOOLS

Study school attendance is compulsory. These engagements are offered virtually or at the SBL campus in Midrand.

For customised offerings, study schools could be offered at a venue of choice by the client.

ON COMPLETION

On successful completion of this programme participants will receive the Management Development Programme Broad-Based Black Economic Empowerment (Normal/Fast Track) Certificate from the Unisa Graduate School of Business Leadership, an internationally respected educational institution.
