**CC:** ICT Sector Measured Entities who enjoy a direct relationship with the ICT Council including Equity Equivalent Investment Programme (EEIP) Measured Entities; ICT Sector Measured Entities who submited B-BBEE Certificates for the Annual Monitoring Reports; ICT Sector Measured Entities belonging to industry associations and bodies represented in the ICT Sector Council and ICT Sector State Owned Measured Entities.

ICT SECTOR COUNCIL (COUNCIL) PRIVATE SECTOR CONTRIBUTION MODEL ANNUAL FEES REVIEW LETTER (2020/2021) PERIOD 1ST MARCH 2020 TO 28 FEBRUARY 2021.

Dear Sir/Madam,

Council has decided that ICT sector entities must confirm that ICT suppliers have contributed to the Council's Private Contribution Model. Contributions to the Council's Private Contribution Model do not result in additional B-BBEE points under Statement AICT 500. Contributions cannot be recognized as Socio-Economic Development (SED) investment under the 2016 Amended ICT Code; Code Series 500; Statement AICT 500.

The Council's Private Sector Contribution Model is a mechanism to determine the value of contributions by ICT entities towards the funding of the operations of the Council. The model is based on the turnover of the entity as per the B-BBEE certificate or affidavit. The 2021/2021 contributions are due on or before 01 December 2021. ICT sector measured entities are required to confirm that ICT suppliers have contributed to the Council's Private Contribution Model.
